

The way of evaluation of the admission examination results for students applying for the BSc study programmes at the Faculty of Architecture, Slovak University of Technology in Bratislava in the 2019 / 2020 school year

1. Evaluation of the tasks worked out by applicants is done anonymously by points allocated to individual tasks. Each task is evaluated by a different, not less than three-member, board. The result of admission examination of an applicant is a summation of the acquired points for individual tasks, whereas all the tasks are equivalent including the Test of general study predispositions. The number of the admitted students is planned ahead and takes into account the qualitative criteria of the admission examination. Admitted are thus students who presented the highest amount of abilities for the study and reached higher number of points (after they have accomplished the basic condition for admission).
2. Each applicant will be assigned a registration number by the Academic Information System (AIS) after he has sent in his/her electronic application form. Since this time, the applicant is registered for the process of admission examination under this number and exclusively only for the purpose of the evidence. This number is delivered to the applicant together with invitation for the admission examination. For the purpose of anonymity during evaluation of the tasks and processing of all results, the drawings have no direct identification, like name, surname of the date of birth, not even the above mentioned registration number. The Faculty uses a two-stage way of anonymity of each applicant. This means that AIS generates based on the registration number of the application form, a five-figure numerical code, the so called first anonymous identification. Based on this, a 21figure alphanumerical QR code will be generated the so called second anonymous identification. This code is taped after finishing each task on the drawing directly before the eyes of the applicant.
3. The evaluation boards, named by the Dean, for individual tasks then review the works of the applicants taped only by the QR code.
4. Evaluation of individual works is done after the talent part of the examination has been finished, that is after all the works have been handed. The results are written directly on the drawings marked by the QR code and then are recorded directly into the list of applicants with anonymous identification. The AIS system will allocate the acquired number of points to each applicant.
5. After the evaluation for all the study programmes has been finished, the AIS will generate the resulting list of applicants ordered according to the acquired number of all points. This list is presented to the admission board. Based on the recommendation of the admission board, the Dean will decide according to the planned number of admitted students the minimum points for passing the examination. The results of the admission examination will be announced to the applicants on the FA STU web site.
6. The applicant will find the number of points that he/she has acquired after entering his/her birth number on the following address: http://is.stuba.sk/prijimacky/verejne_vysledky.pl?lang=sk
7. The day of meeting of the admission board is at the same time, according to § 58 Paragraph 7 Law on Universities No. 131/2002 Coll. the day of confirmation of the other admission conditions. The Faculty will not later than 30 day after this day send to all the applicants the results of the admission examination. It will be sent by registered mail. The applicants who will successfully pass the admission examination and will have passed the school leaving examination, they will receive the final result of their admission examination.
